Who can I speak to about stopping the Bunyip North quarry? What should I tell them?

We're encouraging you to continue to be heard by calling and emailing politicians about why you don't support a quarry in Bunyip North.

You don't have to be a resource or mining expert – because as residents and caretakers of our region, you *are* Bunyip North experts. You know why this proposal is incompatible with this area and your lifestyle – and that's what we need to make our politicians aware of.

Remember, it's the community who can help politicians set a pathway to our region's future - but we can't do that if we're not engaging.

We have included below a list of politicians you may wish to write to, as well as some ideas that you may want to include in your correspondence.

We encourage you to write a few sentences in your own words about your concerns - this will provide more power to your email. We also recommend you to ask questions as this is a great way to communicate with politicians.

And as always, feel free to contact us with any questions you may have – we're here to help!

- By-products of the quarry including:
 - traffic congestion
 - noise
 - dust
 - alteration of landscape
 - vibrations

- The proposal's effect on:
 - road safety, both on local roads and the Princes Highway
 - resident's mental and physical health, including those produced by silica dust
 - the natural world, including endangered fauna and flora
 - local waterways and water sources
 - property and business amenity

- The proposal's proximity to:
 - homes, schools, kindergartens, tourist destinations and places of public interest and gathering
 - places of natural local and state significance including recreation reserves, state parks and bio links
 - primary producers and agricultural businesses

- Concerns regarding the Environmental Effects Statement (EES) process, and whether you believe the community's voice has been authentically heard

- Whether or not you give Hanson a 'social license' to operate in Bunyip North.
